NOTIFICATION OF INTENT TO INVITE BIDS

1. Ministry of National Defence of Romania intends to invite eligible companies to participate at „National Competitive Bidding +” („NCB+”) for the implementation of works of the project *3RS35002 - Provide reception facility at TUNARI, Romania*. The project is included in the Capability Package *CP 9A0996 – Readiness Action Plan – Reception, Staging and Onward Movement (RSOM)* and is commonly funded from NATO Security Investment Program. The procedure NCB+ is “Limited Bidding” which will take place in 2 stages.
2. **Summary Description of Project: 3RS35002 - Provide reception facility at TUNARI, Romania** which include the following increments:

3RS35002-01 – Provide domestic accommodation building (including utilities & furniture)

The project 3RS35002-01 ”Provide domestic accommodation building” is required to ensure all the facilities necessary for NATO troops during staging in support of GRP RD and is programmed in the approved CP 9A0996.

The scope of the project is to provide 4 (four) x fully equipped domestic accommodation buildings (three floors buildings) for 2445 NATO PAX, heating, ventilation and hot water system, electrical installations, water supply system, sewage system, base assembly area and the networks for all increments in the project 3RS35002.

3RS35002-02 – Provide messing block

The scope of the project is to provide 1 (one) with 2 (two) floor building (ground floor and first floor) for 600 PAX/serving, including food heating capacity, distribution lines, tables and seats, sink, heat and cold water, non-subsistence stocks (tableware, cleaning supplies).

3RS35002-04 – RSOM Administrative area and medical facility

The scope of the project is to provide a building with admin offices (including 3 (three) x individual offices, 1 (one) x processing area, 1 (one) x administrative support space, staff toilets, janitor closet), medical facilities (including 1 (one) x administrative support area, 1 (one) waiting room, 2 (two) x medical offices, 1 (one) x treatment area, 1 (one) x storage area, staff toilet, janitor closet, medical treatment fixtures), water supply, electrical wiring, sewage.

The scope of the project is to provide two concrete loading/unloading ramps IAW NATO standards, including access to loading/unloading (one on parking area and one on storage area).

The scope of the project is to provide a gravel platform for storage TEUs, including drainage system to provide both container storage area and maneuverability required to operate containers and demolition of 6 (six) existing buildings.

17. Bidding is conducted according to Governmental Decision no. 114/2011 and is open to all bidders from NATO member countries (“28E”). Only eligible companies from NATO member countries (“28E”) are allowed to participate in the bidding “NCB+”.

All bids shall be accompanied by a Bid Security of 360.000 euro.

The contracting authority shall demand performance guarantee representing 10% of the overall value of the contract.

To qualify for award of the Contract, bidders shall meet the minimum qualifying criteria as specified in the bidding documents. For the qualified companies, the criterion for awarding the contract is **the best quality/price criteria. (70% price, 10% technical experts, 20% technical criteria)**
