Subject: **Notification of Intent** (NOI) to issue an Invitation for International Proposal (IFIP)

1. In accordance with the stipulations of the Bi-SC Procurement Directive 60-70, Annex B, the following information is provided on an Invitation for International Proposal (IFIP) that this Headquarters has the intention to release.

IFIP reference number : ACO-SH-22-27
 Title of IFIP : Management, operation, administration and monitoring of the Building Management Systems (BMS) Network for the SHAPE.
 Requirement : The requirement is for the management, operation, administration and monitoring of the Building Management Systems (BMS) Network of the SHAPE Compound located in Mons, Belgium. Since all BMS networks infrastructures are Local Area Network (LAN) type, all services shall be executed on-site.
 Prospective contractor is to be aware that key contractor's personnel shall possess a suitable security clearance up to NATO SECRET.
 Type of contract : Firm-fixed price.
 Period of performance : One base period (March 1st, 2023 to December 31st, 2023) + 4 (four) one-year options.
 Bidding procedure : Best value.
 Funding : SHAPE budget.
 Estimated total cumulative value of contract (base year + option years): between 800,000 euros and 1,500,000 euros.
 Issue Date : November 2022 planned.
 Bid Closing Date : Janvier 2023 planned.
 Classification of IFIP : NATO UNCLASSIFIED.
 Eligibility : Firms (1) that originate and are chartered/incorporated within one of the NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the NATO-member nations, (3) that possess a valid NATO security clearance up to NATO SECRET level; (4) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation (5) that are legally authorized, at the time of the bidding and afterwards in the event of contract award, to operate the services described in this solicitation in the country where these services shall be provided (i.e. Belgium).
 Partial bidding : It is NOT authorized.
