#### NOTIFICATION OF INTENT

to invite International Competitive Bids to establish

### **Enterprise Agreements for the Provision of Tempest Services**

part of The Enterprise Frequent and Swift Transaction (e-FAST) Contracts

Programme

#### NOI-IFB-CO-115764-e-Tempest

Period of Performance:

A base contract period of three (3) years plus four (4) 12-month option periods

Overall ceiling amount of 30,000,000 EUR throughout the contract life (of 1 three-year base, plus 4 one-year options), whichever occurs first

As part of the e-FAST Program the NCI Agency is seeking to establish Indefinite Delivery Indefinite Quantity (IDIQ) contracts for the provision of Tempest Services.

Through four Schedules the Agency will establish vehicles to expedite procurement of Tempest Services (Schedule A, B, C and D)

The Agency anticipates issuing the formal Invitation for Bids (IFB) by Q4 2022 with an anticipated Contract Award by Q1 2023

- 1. In accordance with References A-D, notice is given of the intent of the NATO Communications and Information Agency (NCIA) to issue an Invitation for Bid to establish Firm Fixed Price (FFP) Singular and Multiple Award Indefinite Delivery Indefinite Quantity (IDIQ) framework contracts. These agreements will cover provision of Tempest Services using multiple funding sources at the NATO Enterprise level.
- 2. A summary of the requirements of the IFB are set forth in Annexes A to D attached to this letter. These requirements are currently being refined as part of the preparation of the proposed IFB.
- **3.** The Enterprise Frequent and Swift Transaction (e-FAST) Contracts Programme is an NCIA Strategic Sourcing Initiative to offer best in class NATO-wide contract vehicles to quickly meet requirements for common services.
- **4.** The reference for this e-FAST IFB is IFB-CO-115764-e-Tempest and all correspondence concerning this IFB should reference this number.
- 5. The policy which identifies the list of potential bidders (who are in compliance with the embedded Reference D policy) is contained at Reference D herein. Those Nations and respective Suppliers who have registered and are certified in accordance with this policy are authorised to provide the services required for this project. The NATO Information Assurance Product Catalogue (NIAPC) are the official owners and custodian of the List of approved Tempest providers (external) companies to be eligible to provide these services.
- 6. National Responsible Authorities are required to nominate these eligible bidders. Any such nominations for companies that do not comply with the Reference D requirements may not participate. Nomination for companies should come from the National Authorities via their Delegation/Mission to NATO, who are invited to provide the requisite Declaration of Eligibility (DoE). Upon receipt of the DoE, the NCI Agency Contracting Officer will add the company to the Bidders List.
- 7. National Responsible Authorities are kindly requested to provide a list to the NCI Agency with Declarations of Eligibility, not later than 21 November 2022, of qualified and certified companies which may be interested in receiving an Invitation for Bids for these requirements. The Declarations of Eligibility should include the following information for each of the nominated firms: Company Name, Point of

- 8. Please note that requests for participation in this competition received directly from individual companies cannot be considered, unless they meet the National Tempest Authority certifications required at Reference D.
- **9.** The successful bidder(s), pursuant to the IFB following this NOI, will be the bid(s) that offers the lowest price and is technically compliant in accordance with the evaluation criteria prescribed in the IFB.
- **10.** The final procurement structure will be detailed in the IFB; however, for reference, the Agency is considering structuring the procurement into the following Schedules:
  - a. Schedule A: Tempest Services Level A for Computers, Displays, Network, Peripherals and Phones; Indefinite Delivery, Indefinite Quantity (IDIQ) framework contract with one supplier as part of the Agency's e-FAST programme;
  - b. Schedule B: Tempest Services Level B for Computers, Displays, Network, Peripherals and Phones; Indefinite Delivery, Indefinite Quantity (IDIQ) framework contract with <u>up to three</u> suppliers as part of the Agency's e-FAST programme;
  - c. Schedule C: Tempest Services Level C for Computers, Displays, Network, Peripherals and Phones; Indefinite Delivery, Indefinite Quantity (IDIQ) framework contract with <u>up to three</u> suppliers as part of the Agency's e-FAST programme;
  - d. Schedule D: Tempest Services for Certified Enclosures for the Agency's CIS equipment; such as certified racks and cabinets; Indefinite Delivery, Indefinite Quantity (IDIQ) framework contract with <u>up to three suppliers</u> as part of the Agency's e-FAST programme;
- 11. The aim of this procurement approach is to maximise competition and value for money; therefore, potential suppliers must be aware that in receiving a place on the IDIQ framework this does not guarantee any commitment for the provision of services. Where specified, the IDIQ framework Suppliers will be required to further compete for specific requirements under a Request for Quotation (RFQ) competitive process for respective Task Orders.
- 12. Potential suppliers are allowed to bid under this IFB for any or all Schedules, in

accordance with the IFB instructions.

- **13.**National authorities are advised that the IFB package is anticipated to be NATO UNCLASSIFIED; however, the IFB and the contractual documents could contain references to other NATO documents classified as NATO RESTRICTED.
- 14. The successful Bidder(s) may be required to handle and store classified information up to the level of NATO SECRET. In addition, Contractor personnel may be required to work unescorted in Class II Security areas and therefore, access can only be permitted to cleared individuals. Only companies maintaining such cleared facilities and the appropriate personnel clearances will be able to perform the resulting Tempest contract (Schedule A, B, C and D).



## Annex A – Schedule A: Tempest Services Level A Indefinite Delivery, Indefinite Quantity (IDIQ) framework Contract Summary of Requirements

#### 1. Introduction

- a. The Enterprise Frequent and Swift Transaction (e-FAST) Contracts Programme is an NCIA Strategic Sourcing Initiative to offer best in class NATO-wide contract vehicles to quickly meet requirements for common services.




