Subject: Notification of Intent (NOI) to Issue an Invitation for International Competitive Bidding (ICB) for Facility Maintenance and Support Services at NATO Alliance Ground Surveillance Force.

1. In accordance with the stipulations of the Bi-SC procurement Directive 60-70, Annex C, the following information is provided on an Invitation for International Competitive Bidding (ICB) that this Headquarters has the intention to release.

IFIB Reference Number : ACO-NAGSF-20-09

Title of ICB : Facility Maintenance and Support Services

Requirement : Provision of facility maintenance and cleaning services to buildings under NATO AGS Force area of responsibility at Sigonella AirBase. NATO Security Clearance at NATO SECRET level is required for the awarded Contractor and its personnel.

Type of contract : Firm Fixed Price Contract

Period of performance : Base Period: One year (1 Jan 2021 thru 31 Dec 2021); Options: four (4) one-year contract periods.

Bidding procedure : Lowest Price Technically Compliant Bid. Competition will be conducted on ACO Electronic Bidding Portal (<https://aco.procureware.com>). Firms interested to participate are invited to apply for registration on the portal to become an approved vendor.

Funding : Military Budget (BC 167). Estimated Contract Value: Base Period (1 year) 1,200,000 Eur. Estimated total contract value (including options if exercised) 6,000,000 Eur.

Classification : NATO UNCLASSIFIED

Issue Date : Jun 2020 (planned)

Closing Date : July-Aug 2020 (planned)

Eligibility : ***Governmental and/or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-member nations and (3) that provide funding for the afore mentioned requirement. Vendors shall have performed at least three (3) contracts within the last five (5) years substantially similar in scope, complexity and magnitude to the requirement described in the NAGSF solicitation. All above must be supported by Past***
