Option Periods: Possibility of 4 option years. Option years are subject to annual review and granted extension.

Bidding Procedure: Sealed Bidding, Three-Envelope method

Funding: 255 O&M Budget. Estimated magnitude of award: Minimum 5,500,000 NOK over a possible 5 year period. Subject to funding: Military Budget.

Bid Closing Date: 15 September 2020, (target date)

Award: LOWEST PRICE TECHNICALLY COMPLIANT

Eligibility: Governmental or Commercial entities (1) that originate and are chartered/incorporated within NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within NATO-

member nations and (3) that provide the funding for the aforementioned requirement. Companies which have performed similar contracts within the last three years substantially similar in scope to the requirement described in the solicitation. Contractor personnel performing services under the contract must be citizens of a NATO nation and have appropriate professional training and experience in a related field(s).
