The assignment includes engineering design and erection (turnkey contract) of two new buildings in Jåttå camp for Joint Warfare Centre (JWC) in Stavanger. The buildings will be discussed as G block and warehouse. G block will be a multi-function building, and will be used by different sections and departments at JWC. G block will, among other things, contain:
— check-in areas,
— registration counters,
— auditorium,
— office work spaces,
— premises for the Media Department Sound studio with a requirement for sound insulation and acoustics,
— communication room,
— changing room/wet room G block consists of three stories, and will have external access to all three stories. There is a separate stairwell from level two to level three, and with access and bridge to the upper level of the facility, where the entrance to the existing main building is located.
In connection with the G block, a separate luggage area has been arranged, which is located next to the building itself. This is built in concrete, and is a naturally ventilated building with space to store luggage for

personnel who need temporary storage. The number of work spaces will vary from a minimum of 25 — 30 to a significantly higher number during exercises.

G block is approx. 2 100 m².

The site must be prepared and an outdoor area adapted to this will be established.

A warehouse will be established with a connection to the existing values. The site will be facilitated to remove rocks, and these are located closely to the existing buildings.

The storage will consist of two stories. Arrangements are being made for goods reception to be on the 1st floor. A large storage area will also be established here. Office spaces will also be allowed for in this section. Cubicle offices and an office landscape will be established on the 2nd storey.

Storage is approx. 900 m².

The project will be implemented as a turnkey contract in accordance with NS 8407.

Notification of Intent to Invite Competition in accordance with NATO National Competitive Bids Plus (NCB+) Procedure

PROVISION OF SUPPORT FACILITIES FOR JOINT WARFARE CENTRE, STAVANGER, NORWAY

1. Background

Norwegian Defence Estates Agency (NDEA) - on behalf of MOD Norway - intends to run a competition for the provision of support facilities for the NATO Joint Warfare Centre (JWC) located in Stavanger, Norway. The competition is announced in agreement with the rules and procedures for National Competitive Bidding Plus (NCB+) as defined for the NATO Security Investment Programme. The contract to be established is of a Civil Works nature.

With this notification document, NDEA would like to ensure that eligible firms from any NATO member nation participating in the funding of the project are informed and invited to participate in the competition.

2. Scope

The scope of the project covers provision of two separate buildings. One building will have three levels with a total size approximately 2 000 m². The building will include facilities for simulated news and media production and reception facilities in support of receiving visiting staff to the JWC.

The second building will be a two level warehouse with a total size approximately 1 000 m².

The value of the contract, which will cover both buildings, is estimated to 10 – 14 million Euro exclusive of VAT.

Interested firms will be subject to a pre-qualification process and only those firms, which are pre-qualified, will receive the invitation for tender documents and are qualified to submit a bid.

3. Security.

The main invitation to tender document to be issued to pre-qualified firms will be unclassified. However, some information is classified NATO RESTRICTED, and bidding firms will be given access to this classified information by visiting NDEA's facility in Stavanger, Norway. The invitation to tender document will be written in the Norwegian language.

Most contractor personnel, who will require access to the construction site, must have a valid NATO Security clearance of NATO SECRET.

4. Time schedule

Firms interested in participating in the pre-qualification for this project are requested to show interest via the Tenders Electronic Daily (TED) database (ted.eu) on Internet no later than 30 March 2021 at 12:00 Central European Time. The announcement on TED has the following reference: TEDB8/2021-316831 and is also enclosed this document.

The plan is to sign a contract by September 2021, start works on-site in Stavanger in August

2022 and complete the project by June 2024.
