On 14 June 2022, the Investment Committee noted Estonia's intention to pre-finance enhancement of Reception, Staging and Onward Movement (RSOM) facilities¹ at Tapa base, and agreed on the procurement procedure of National Competitive Bidding Plus (NCB+). Estonia is pleased to invite all eligible firms from NATO countries to take part in the bidding process.

This Notification of Intent applies to the construction procurement for the RSOM facilities, with an estimated (unadjusted) value of 6 400 000 euros.

The bidding documents will be "NATO RESTRICTED".

Estonian Centre for Defence Investment (ECDI), governed by the Estonian Ministry of Defence, is responsible of conducting all defence related procurements. The bidding process will be conducted in two phases:

Phase I: qualification – submission of application documents, deadline is 20 July 2022.

Phase II: submission of bids – duration of 25 days from decision on qualified bidders.

The tender release date for the procurement was 17 June 2022 and estimated bid closing date is on **5 September 2022**. **However, these dates are subject to change during the tender process, all final deadlines will be set in the procurement notice in the e-Procurement registry.** The contract for the project will be awarded to the lowest compliant bidder. Bidders will be required to declare a bid validity of three (3) months from the closing date for receipt of bids.

All potential bidders will have to create user and company accounts on the e-Procurement portal (<https://riigihanked.riik.ee/rhr-web/#/settings/users/new>) for the submission of bid proposals and all relevant documentation. Any other method for bid proposal (mail, e-mail, fax, via Estonia's delegation to NATO) will not be accepted and such bid proposals **will not be considered** after the bid submission end date.

Declarations of eligibility, as per Annex V to AC/4-D/2261 (1996 Edition), shall be submitted from national delegations to the Estonian Delegation at NATO (mission.nato@mfa.ee) and the ECDI (Mrs Ave Nael, e-mail ave.nael@ecdi.ee)

In case of need for clarifications on the bid proposal, the ECDI can ask for additional or original documents, including using channels other than the e-Procurement registry.

The bid documentation and subsequent procurement contracts will be in English. Bid offers and all communication made by the bidders, including any technical data or documentation submitted by the contractors must be also in English.


