

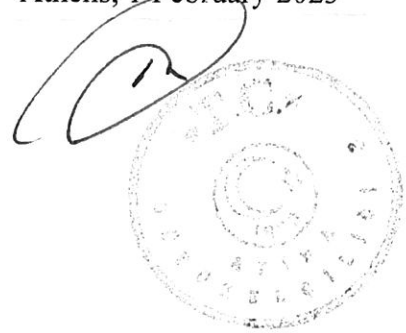

1. The Ministry of National Defence of Türkiye (MoD) intends, in accordance with reference, to invite eligible to participate at National Competitive Bidding + (NCB+) for the implementation of works of the Prefinanced Project 3NB 19023-0 "Construction of Quay, Piers and Other Facilities" in Aksaz Naval Base.
2. An overview of the requirements for this IFB is as follows: All the below items will be constructed according to NATO Maritime Facilities Criteria and Standarts (Bi-SC 085-008), national/international maritime design construction criterias and related legislations.
 - a. Quay, Piers and Other (Auxiliary) Facilities,
 - b. All serviceability requirement of the Quay and Piers (sewage water, domestic water, rain water, waste water, pressured air, bilge water, fire water, fuel, electricty, communication, battery charcing/discharging, lighting, etc.),
 - c. Huge amount of hard material excavation and Quay back site filling,
 - d. Location: Aksaz – Marmaris /Muğla.
3. **Method of Bidding:** National Competitive Bidding + (NCB+)
4. **Bidding Information:**
 - a. Companies from NATO member countries which are interested in participating in bidding be introduced by their National Delegations to NATO or Embassies in ANKARA through Ministry Foreing Affairs/Türkiye with the required Declaration of Eligibility document, before the eligibility closing date. The Declaration of Eligibility document should be submitted using the NATO form, which is available on the document AC/4-D/2261, Annex V. Application for participation directly from the firms shall not to be consider.
 - b. It should be known that the technical, financial and professional decision of the candidate companies to be selected to participate in this tender has done or currently doing or has the capacity to do any of the **Maritime Facilities** (pier, quay etc. with all the serviceability requirements) needs to be taken by the bidder's country.
 - c. It is kindly requested that the list of approved companies, which are candidates for participation in this tender, be notified to the Ministry of National Defence not later than 13 March 2023 (latest 18:00 local hours). The list of be notified should include the company's name, telephone and fax number, e-mail address and the personal to be contacted. This information is important in order to ensure correct and fast communication with the companies that intend to participate the tender and should be sent to the address below:
