### **Summary of Requirements**

The NCI Agency is seeking a NATO nation based industry partner to provide a solution to improve management of hardware obsolescence from re-active to pro-active and commission a list of IT equipment to address obsolescence management requirements and facilitate a technology refresh.

Capital Expenditure (CAPEX) and Operational Expenditure (OPEX) cost models are potentially valid options. To make better consideration, the NCI Agency is seeking to improve understanding of OPEX cost models, subscription models and service descriptions for lifecycle management of IT equipment and understanding of components available solutions/services would consist of, based on market availability.

Equipment will need to be delivered to Belgium, additional components will be deployed at various geographical locations, including Mons and Brussels (BE), Lago Patria, Poggio Renatico, La Spezia (IT), Brunssum, The Hague (NL), Izmir (TR), Northwood (UK), Norfolk VA (US), Aix en Provence (FR), Munich, Uedem, Ramstein and Geilenkirchen (DE), Capellen and Betzdorf (LU), Torrejon (ES), Stavanger (NO), Monsanto (PT) and Bydgoszcz (PL).
