

conduct an assessment / a study of the SCC conditions on its current energy consumption and evaluate the efficiency of the electrical power / cooling capacity; develop a comprehensive picture of the functional performance of the building infrastructure; analyse the collected data propose a replacement programme to renew / upgrade existing power

capabilities.
