1. The purpose of this Amendment# 4 is to:

3. Due to the urgency of this project, this will be the last bid closing date extension granted. Also no further questions on the original IFB package will be answered but only questions on the answers provided (following the timelines specified in paragraph 2.7.4 of the Bidding Instructions.)
4. Revised bidding documents are provided with this IFB Amendment# 4 as Attachment 1 and replace the original versions in their entirety. Potential Bidders are strongly advised to carefully review these revised bidding documents. With the exception of the revisions included in these documents, all other IFB documents remain unchanged from their original version as issued on 12 October 2023.
5. Prospective Bidders are advised that the NCI Agency reserves the right to cancel this IFB at any time in its entirety and bears no liability for bid preparation costs incurred by firms or any other collateral costs if bid cancellation occurs.
