Subject: Notification of Intent (NOI) to Issue an Invitation For International Bid (IFIB) for the supply of natural gas power to SHAPE (Mons, Belgium).

REFERENCE: Bi-SC Procurement Directive 060-070 dated 30 June 2015.

1. In accordance with the stipulations of the Directive at Reference, Annex C, the following information is provided on an Invitation for International Bid (IFIB) that this Headquarters has the intention to release.

IFIB reference number : ACO-SH-24-07
Title of IFIB : Supply of natural gas power to SHAPE.
Requirement : The requirement is for the provision of natural gas and off-take at the Off-take Points.
Type of contract : Firm-fixed price.
Estimated Value : SHAPE Military Budget (estimated yearly amount: 1 MEURO). Reimbursable budgets (estimated yearly amount: 500 KEURO). Estimated total cumulative value of contract: 4.5 MEURO.
Period of performance : Three years (2025-2027).
Bidding procedure : Lowest price technically compliant bid.
Funding : SHAPE military budget + Reimbursable budgets.
Classification : NATO UNCLASSIFIED
Issue Date : April 2024, planned.
Closing Date : May/June 2024, planned.
Eligibility : This IFIB is open to proposals from firms that (1) originate and are chartered/incorporated within NATO-member nations; (2) maintain a professionally active facility (e.g. office, factory, laboratory) within NATO-member nations; (3) are legally authorized, at the time of the bidding and afterwards in the event of contract award, to operate the services described in this solicitation in the country where the services shall be provided (i.e. Belgium). The bidder shall be in possession of a legal licence for the supply of natural gas power within the Walloon Region of Belgium at the time of bidding and throughout the whole duration of the contract.
Delivery location(s) : SHAPE (Mons, Belgium).
Partial bidding : Is not authorized.
