The NCI Agency hereby notifies the NATO Nations of its intent to invite bids for the procurement of Wireless Centralised Management Interface. The scope of this upcoming opportunity is anticipated to develop and implement a mediation platform designed to support the coordination of NATO services delivery through national access points, henceforth referred to in this document as Wireless Centralised Management Interface (WCMI). This platform shall be based on central node that collects service delivery related data from the different national providers and offers planning, monitoring and business intelligence capabilities to ensure the required Service Levels for the end users. The Project 2015/OCM03069 is included in Capability Package (CP) 9A0101 "Wireless Communication Transmission Services other than SATCOM", approved by the North Atlantic Council at C-M(2015)0042-AS1.
