1. At the Steering Board at Reference, the independent Programme Office (iPO) informed NATO Nations of the intent to execute early Industry Engagement for the enhanced NATO Air Command and Control capability (eAirC2). The purpose of this letter is to **inform NATO Nations of the planned Industry Events and to seek information on potentially interested industrial entities**.
2. The aim is to introduce the work of the iPO and provide an overview of eAirC2 to compile a list of interested industries.

In order to maximize participation from Industry in this early engagement, the iPO and NCIA Agency plan to host two dedicated Industry event sessions to present programmatic and technical aspects of the project, and, to the extent possible, answer related questions. The NCIA has scheduled two event dates: 2<sup>nd</sup> April and 16<sup>th</sup> April 2025, and intends to hold them in a virtual format using the NCIA Event WebEx to reach a wider audience.
4. Subsequent to the Industry Event, industrial entities will be invited to arrange a meeting with the iPO and NCIA representatives to discuss the capabilities of the firm in future engagements.
