Requirement	:	The requirement is for the provision of office furniture (desks, chairs, cabinets, drawers, etc.) for SHAPE HQ located in Belgium.
Type of contract	:	Indefinite Delivery, Requirements type contract
Estimated value:	:	300,000 EUR per year. Estimated total cumulative value of contract: 1,500,000 EUR
Period of performance	:	One base year (2026) + four one-year options
Bidding procedure	:	Lowest price - technically compliant bid
Funding	:	SHAPE Budget (estimated 70 % of the yearly amount) Reimbursable budgets (estimated 30 % of the yearly amount)
Issue Date	:	August 2025, planned
Closing Date	:	October 2025, planned
Eligibility	:	Firms (1) that originate and are chartered/incorporated within one of the NATO-member nations, (2) that maintain a professionally active facility (office, factory, laboratory, etc.) within one of the NATO-member nations, (3) that have performed at least three contracts within the last five years substantially similar in scope and magnitude to the requirement described in the solicitation.
