The NCI Agency hereby notifies the NATO Nations of its intent to invite bids for the procurement of a modern IPTV and Digital Signage (DS) solution that serves 40+ IPTV channels, 3 NATO TV channels and 12 Digital Signage over the NATO HQ public network. The content is broadcasted to the entire NHQ user community: IS, IMS, Delegations and Military Representatives. The solution has to be fully owned and operated by the industry partner, including all levels of support and hardware maintenance and replacement. All vendors need to comply with all regulatory requirements for providing IPTV services in Belgium, including but not limited to: a license from the Belgian Regulatory Authority (BIPT), compliance with EU broadcasters regulations, content licensing rights and GDPR conformity.

- 1. In accordance with References A through B, the NCI Agency, as the Host Nation responsible to implement the project in subject, hereby gives notice of its intent (NOI) to issue an Invitation for Bid (IFB) for Provision of IPTV and Digital Signage for NHQ, hereafter referred to as the "Project".
- 2. A high-level summary of the Project's technical requirements is set forth in Annex A hereto. These requirements are being refined and will be included in further details as part of the IFB.
- **3.** The reference for this Project is NOI-CO-424243-IPTV-DS, and all correspondence concerning this NOI and subsequent IFB should reference this number.
- 4. The NCI Agency will use the Basic Ordering Agreement (BOA) Plus bidding procedures. Annex [C] attached to this letter contains a list of potential bidders which may be able to provide the products or services required for this Project. This list was compiled from companies already holding an active BOA with the NCI Agency.
- 5. In addition to the companies listed in Annex C the BOA Plus procedures allow national authorities to nominate eligible bidders without an active BOA. Hence, qualified and certified companies interested in receiving the IFB for this Project are hereby requested to provide a Declaration of Eligibility (DoE), sent by their Delegation/Mission to NATO to the NCI Agency contracting authority not later than 18 July 2025, which is [10] calendar days after the date of this letter.

- **a.** In addition to the certification of the company's security clearances required under this NOI, the DoE should include the following information for each of the nominated companies:
 - Company name
 - Company address
 - Point of Contact (PoC)

- PoC telephone number
- **b.** This information is critical to enable prompt and accurate communication with prospective bidders and should be <u>424243-IPTV-DS@ncia.nato.int</u>.
- 7. In order to maximize competition the NCI Agency may, at its discretion, accept nominations after the deadline, as long as the IFB has not been issued. The NCI Agency may even accept, at its discretion, nominations after the IFB has been issued under the condition that such late nomination will not be used as the basis to request an extension to the bid closing date.
- 8. Requests for participation in this competition received directly from individual companies will not be considered.
- **9.** Bidders will be required to declare a bid validity of 12 months from bid closing date. Should the selection and award procedure exceed the bid closing date by more than 12 months, companies will be requested to voluntarily extend the validity of their bids accordingly. Bidders may decline to do so, withdraw their bid and excuse themselves from the bidding process without penalty.
- **10.** National authorities are advised that the IFB package is anticipated to be NATO UNCLASSIFIED. However, the IFB and the contractual documents could contain references to other NATO documents classified as NATO UNCLASSIFIED.
- 11. The successful bidder will be required to handle and store classified information up to the level of NATO UNCLASSIFIED. In addition, contractor personnel will be required to work unescorted in Class II Security areas. Therefore, access can only be permitted to cleared individuals. Only companies maintaining such cleared facilities and the appropriate personnel clearances will be able to perform the resulting contract.
- 12. The NCI Agency reserves the right to cancel, suspend, or withdraw this NOI at its own discretion and at any time. The NCI Agency is not liable for any expenses incurred by companies in conjunction with their responses to this NOI and such responses shall not be regarded as a commitment of any kind concerning future procurement of the items or services described herein.

Annex A – Summary of Requirements

1. Project Objective

To replace the NATO HQ outdated IPTV and Digital Signage (DS) system with a modern, state-of-the-art alternative. The proposed solution shall be designed to operate on the NATO HQ public network and deliver 40+IPTV channels, 3 in house generated channels and 12 DS channels. The solution shall be contractor owned and contractor operated. Currently there are 320 devices (smart TVs and Set-Up Boxes) which need to be replaced with modern IPTV and DS capable smart TVs/displays. A video wall is also connected to the system and it needs to further be supported.

2. Scope of Work

The technical solution, including all software and hardware components. Project management of the implementation phase, including monitoring, schedule and reporting. The installation of the new IPTV solution, Digital Signage capabilities including all required hardware and software customisations. Any required accreditation and certification of the service to run on the NATO HQ public network. All supply and maintenance of provisions for the service including up to 12 channel changes per year. As well as comprehensive Operation & Maintenance (O&M) including technical support and training. O&M shall cover on-site support with required response times (restore target: 2 working days – P3), routine maintenance, updates, and periodic security testing.

3. Period of Performance

a. The Period of Performance is anticipated to start in Q4 2025 and end in Q4 2030. It is important to note that this timeline represents the anticipated duration of the Project, and adjustments may be made as per the requirements of the solicitation process and subsequent contractual agreement.

4. Technical Constraints

All vendors shall have the capacity for on-site maintenance and support in a window of 4 working hours for P1 incidents. Also mandatory is the compliance with all regulatory requirements for providing IPTV services in Belgium, including but not limited to: a license from the Belgian Regulatory Authority (BIPT), compliance with EU broadcasters regulations, content licensing rights and GDPR conformity.

5. Warranty and O&M Support

- a. Following acceptance of the final operational delivery, the contract will require warranty for any software delivered.
- b. The contract is expected to include O&M support following acceptance of the final operational delivery.]
