**Title of IFIB:** 360 Exercise Setting/Scenario Production

**Requirement:** JWC is seeking contracted service support to fulfill its need for exercise environment, setting, and scenario development primarily on-site, with off-site support in exceptional cases.

JWC intends to establish multi-award framework contracts under which tasking orders will be issued at agreed rates throughout the duration of the contracts.

**Type of Contract:** Indefinite Delivery Indefinite Quantity (IDIQ) Contract.  
Firm-Fixed Price (FFP)

**Period of Performance:** Base Period: January 1, 2027 – 31 Dec 2027-(Anticipated)

**Option Periods:** Option Year 1 - 01 Jan 2028 - 31 Dec 2028  
Option Year 2 - 01 Jan 2029 - 31 Dec 2029  
Option Year 3 - 01 Jan 2030 - 31 Dec 2030  
Option Year 4- 01 Jan 2031 – 31 Dec 2031
