## **Introduction**

NATO Joint Analysis, Training and Education Centre (JATEC) intends to award contract/s for the following finance governance contractors:

- Travel Operations and NATO Financial System Support Specialist
- Non-NATO Personnel Financial Operations Support Specialist

The JATEC hereby notifies the following Procurement Opportunity in accordance with the Procedure for NATO Competitive Procurement. This notification is issued to foster open and fair competition among eligible vendors from participating nations. This notification does not constitute a commitment to award a contract.

The JATEC will allow partial bidding.

Bidders are invited to review the requirements described herein and to register for participation through the appropriate national authority of the prime bidders's nation of origin. Bidders may form partnerships or sub-contractor relationships, however all vendors, whether prime, partner or sub-contractor shall meet all identified eligibility requirements for participation.

This opportunity reflects NATO's commitment to transparency, equal treatment of suppliers, and the efficient delivery of goods, works, and services in support of NATO missions and participating nations.

All eligible and responsible sources may submit a proposal, which shall be considered by the JATEC.

## **2. Description of Requirement**

The mission of the Joint Analysis, Training and Education Centre (JATEC) as one of the strategic pillars of the NATO - Ukraine evolving jointness is to provide for the NATO - Ukraine interoperability, to contribute to the development of NATO and Ukraine's transformation in defence, deterrence, crisis prevention, crisis management and cooperative security. The JATEC, as the first joint NATO-Ukraine civil-military organization, plays a transformative role in enhancing collective security. It serves as a catalyst for strengthening NATO-Ukraine relations and delivering rapid solutions and long-term benefits for both NATO and Ukraine.

The Office of Budget and Finance (O/BUDFIN), operating within the Staff Advisory Group (SAG), is responsible for financial planning, budgeting, financial reporting and the implementation of ACT financial management policies in support of JATEC activities. The two finance governance support contractors will be aiding the O/BUDFIN in handling the financial activities related to NON-NATO personnel and travel operations as well as functional support for financial processes associated with multinational personnel supporting JATEC activities.

## **3. Vendor Eligibility**

**3.1.** Participation in this Procurement Opportunity is restricted to bidders from participating nations. Bidders from other than participating nations shall be excluded from serving as prime contractor or subcontractor.

**3.2.** Bidders (partners and subcontractors) must hold a NATO Facility Security Clearance (FSC). The Proposed team must hold NATO SECRET clearance.
